IMPACT OF INCARCERATION

The effects of widespread incarceration have been catastrophic. Today, nearly 2 million people are locked behind bars in America. (Sawyer & Wagner, 2023) Rather than reduce crime, prisons regenerate the very issues they aim to destroy. A study conducted by the American Bar Association's Criminal Justice Section reported that people with criminal convictions face an additional 38,000 collateral consequence statutes, or added punishments and barriers, nationwide. (Dolan & Carr, 2015) Upon release, many people are escorted outside of their facilities and given nothing but a couple hundred dollars in "gate money." These individuals often return home to deal with complicated family relationships, challenges in finding employment, triggering environments, substance and mental health disorders, and much more, with little to no guidance or support. It is not surprising, then, that nearly half of those exiting from state prisons will be rearrested within the first year of their release. (Rogers, 2023)

California alone spends \$15 billion a year on its criminal justice system. (Cicero Institute, 2019, as cited in "The 2019-20 Budget", 2019)

60% of individuals released from prison in California will re-offend within three years. (Rogers, 2023)

Four out of five Californians on parole are unable to obtain a job during their first year out of prison. (Cicero Institute, 2019, as cited in Petersilia, 2006)



CREATION OF THIS GUIDE

Reentering society after incarceration presents significant challenges for many individuals, such as finding employment, housing, and rebuilding relationships. Access to resources and support is crucial for overcoming these obstacles and reducing recidivism rates. By creating a comprehensive resource guide, Starting Over Inc. aims to address these challenges and increase the likelihood of success for those seeking to start anew.

The creation of this guide was informed by the first participants of an employment readiness class called Path2SEED at Starting Over Inc. Community-based participatory research methods were employed, including surveys and focus groups, to ensure the guide applies to the re-entry experience in Riverside County. Thank you to those who shared their stories and advised the creation of this guide.

A survey conducted with participants of the Path2SEED employment readiness program explored the experiences of formerly incarcerated individuals during their re-entry process. Specifically, the most significant barriers they have faced throughout their re-entry, the types of support that have been helpful, and areas where more support is needed were discussed. It was apparent that obtaining employment was a primary concern for these individuals. While employment is a critical component of successful re-entry, unfortunately, significant barriers prevent formerly incarcerated people from securing jobs. Statistics show that 40% of employers would not consider someone for a job if they had a criminal record. (Galloway & Duane de la Vega, 2016) Participants of Path2SEED confirmed these statistics with their own experiences. One respondent explained, "Biggest barrier I've found was my criminal record. It prevents me from getting jobs that can better help my situation, although I am more than gualified for the position." Others reported similar experiences, noting that their criminal history overshadowed their abilities and made it difficult even to land an interview; "Very limited consideration for jobs I have applied for. I'm judged before getting to know me personally." Participants also identified transportation, technology skills, housing, travel, identification, and other issues as significant obstacles to successful re-entry.



The survey also highlighted several areas where additional support is needed for formerly incarcerated people. This included the development of career skills along with business and entrepreneurship classes. Additionally, many respondents felt that the re-entry process should begin earlier, during probation or even while still incarcerated. For example, one person suggested apprenticeship programs during probation to help individuals work towards long-term career goals. Others noted that it was difficult to obtain updated information while still in prison, which made it challenging to prepare for release.

Finally, respondents emphasized the importance of support during the re-entry process. Many credit Starting Over for providing valuable resources and a welcoming community. One participant noted, "SOI helps me feel more confident with getting a job and supporting me in building my resume." Another explained, "I did not really reach out to the community until working with Starting Over. I'm thankful for the help and aid I've been receiving through them."Another respondent, who had been released only three weeks prior, stated, "My community is Starting Over Inc for the most part, they have played a big role."

Given that 93% of people that are incarcerated are eventually released, it is imperative that we give this community the care that they deserve. (Petersilia, 2006) Based on the feedback provided by individuals going through the reentry process themselves, this guide is an attempt to address these issues and provide support to those impacted by the system.

PRIOR TO RELEASE: CDCR PROGRAMS

- There should be various different <u>activity groups, educational</u> <u>programs, treatment programs, and pre-release programs</u> available to those incarcerated in CDCR facilities.
- Library services are available at all institutions and accessible to any incarcerated individual upon request. You may be able to ask your prisons law librarian to access internet resources for you while inside in order to help prepare you for release or get other necessary information.
- <u>Pre-Release Community Programs</u> allow eligible incarcerated individuals committed to state prison to serve the end of their sentences in the community, in lieu of confinement in state prison. There are several other programs available to provide a wide range of rehabilitative services to promote rehabilitation and reintegration into the community. These include;
 - Custody to Community Transitional Reentry Program
 - Alternative Custody Program
 - Male Community Reentry Program
 - Community Prison Mother Program



TRANSPORTATION

- If incarcerated at any of the five Riverside County jails, individuals should receive a bus pass from the jail they are being released from to get to where they need from there.
- Warm Hand-off Program: Starting Over Inc. offers this service to address people's urgent needs within the first 24 hours of their release. This program helps those returning to Riverside or San Bernardino County upon their release by providing them with transportation from the place of incarceration to their parole officer or halfway house while offering them re-entry needs assessment resources.

- Transportation services are available to those on probation or parole, disabled, or low-income. Call (951) 955-1530 to get a ride to court, probation check-ins, or other necessary appointments.
 - This service is based solely on availability and is not guaranteed until the day before the ride is needed, although rides can be requested months in advance.

 - Transportation available between 9 am-3:30 pm
- <u>**Riverside Transit Agency</u>** day passes can be purchased on the bus, while 7 and 20-day passes can only be ordered online, through the mail, or from a pass sales outlet.</u>

 - <u>Dial-a-ride</u> is an advanced reservation transportation service available to seniors and people with disabilities.
- <u>OmniTrans</u>: you can buy passes online or with the <u>transit app</u> (reduced prices for veterans, seniors, and disabilities and free fares for K-12 students)
- <u>Metrolink</u>: you can buy tickets online, in-person at the ticket machines, or print passes at home.

PUBLIC BENEFITS

Public benefits include different forms of government-funded assistance. You must qualify for public benefits based on income or other factors to receive this assistance, generally geared towards funding low-income individuals and families.

Cal-Fresh: California's food stamps program provides those enrolled with money to buy food.

CalWORKs: A public assistance program that provides cash aid and services to eligible California families in need.

Medi-Cal: California's Medicaid program that pays for a variety of medical services for those that cannot pay themselves.

WHAT IS A HOUSEHOLD?

A "household" can be one person, or any group of people who live together, buy food, and make meals together. If you live with other people but buy and prepare food separately from them, you can apply for food benefits as part of a separate household. Spouses, parents, and children under age 22 who live together must apply as a single "household."



You can see if you qualify and can also apply for Cal-Fresh, Medi-Cal, and CalWORKs through one application at <u>https://benefitscal.com/</u>

The application should take between 30-60 minutes. You should fill out as much as you can and be ready to share about the money you earn and spend.

Once you submit your application, you may be asked for proof of identity, income, and expenses later on.

CalFresh and CalWORKs applicants are required to be interviewed by phone or in person. Medi-Cal does not require an interview.

OBTAINING YOUR IDENTITY DOCUMENTS AND PERSONAL RECORDS

THESE PAGE'S HAVE BEEN ADAPTED FROM ROOT&REBOUND'S ROADMAP TO RE-ENTRY

Having your identification documents is important for many reasons, including employment, housing, education, medical care, public benefits, transportation, voting, banking, and more. A prison or jail I.D. may be sufficient in helping you get other forms of identification in the early days of your release, but this will not be a sufficient form of identification for long.

The most essential forms of I.D. are your birth certificate, social security card, and a state ID or driver's license. Once you obtain your birth certificate and social security card, you can obtain a state I.D. or license along with other forms of identification.

Please note that many places will require the original form of these documents rather than a copy.

HOW TO GET YOUR BIRTH CERTIFICATE:

If you were born in California, obtaining your birth certificate through the County Recorder's Office is recommended, as it will take less time than the California Department of Public Health. Although to go through the County Recorder's Office, you need to know the county you were born in.

- **County Recorder's Office**: Use this state-wide directory to locate the office in the county you were born in.
 - In-person requests
 - Step 1: Call ahead and ask the office how they will have you identify yourself to see if they will accept the forms of ID that you have. Make an appointment if necessary.
 - Step 2: Go into the office to identify yourself and fill out and submit your application. Be prepared to give the following information;
 - Birth name, birth date, the city you were born in, and your parent's names, including both of their maiden names
 - Step 3: Pay the fee (varies by county)
 - By-mail requests
 - Step 1: Request a copy of the specific birth certificate application from the county you were born in by phone or mail or download it from their website. Then, complete it to the best of your ability.
 - Step 2: Sign and have your Sworn Statement notarized
 - Step 3: Prepare the fee payment (varies by county)
 - Make sure to check with the office about what forms of payment they will accept. Sending cash by mail is generally not recommended.
 - Step 4: Mail all materials to the County Recorders Office.
 - Online requests: Your County Recorder's Office will also likely have an online application available. Once locating the office in the county you were born in, visit their website to check.

• California Department of Public Health (CDPH): If you do not know what county you were born in, the CDPH can help you get a copy of your birth certificate but may take slightly longer to process your application. There is no in-person option for this method either.

- By-mail requests:
 - Step 1: Download a copy of the application
 - Step 2: Sign and have your Sworn Statement notarized
 - Step 3: Prepare the fee payment (\$29, subject to change)
 - Step 4: Mail all materials to CDPH Vital Records
- <u>Online requests</u>: Order through VitalCheck, State Vital Records, or Vital Records Online.

If you were born outside of California but within the U.S., the procedure for your individual state will need to be followed.

- Step 1: Find the Vital Statistics Office in your birth state. The CDC has a record of these on its <u>website</u>.
- Step 2: Call, write, or browse the website of the Vital Statistics Office in the state where you were born and ask what they need from you to obtain an authorized copy of your birth certificate.

If you were adopted and don't know where you were born, request an application for a certified copy of your birth certificate in the state you were adopted in, using your adoptive name.

If you are a naturalized citizen, you should have been issued a Certificate of Naturalization when you became a citizen, which can act the same as a birth certificate in terms of getting other forms of ID. You can <u>apply for a replacement</u> of this document if you don't have it. If you were born outside of the United States but are a U.S. citizen due to your parent's citizenship, your birth should be registered with the U.S. Consulate or

Embassy, and the U.S. Department of State should have given them a Consular Report of Birth Abroad of a Citizen of the United States of America (CRBA).

- Step 1: Prepare a written or typed request, including
 - Your full name at birth and any adoptive names you had
 - Your birthplace and date.
 - Your parent's full names
 - The serial number of your Consular Report of Birth Abroad (Form FS-240), if you know it.
 - Any available passport information.
 - Your mailing address and phone number
 - Your signature (wait until you go to the notary to complete this step)
- Step 2: Get your request notarized by a Notary Public.
- **Step 3:** Prepare a check or money order for \$50, not cash. Make it payable to the "Department of State."
- Step 4: Mail your request and fee

If you were born in another country and are not a U.S. citizen, contact your birth country's nearest Embassy or Consulate in the United States. Addresses and telephone numbers for these offices are listed in the U.S. Department of State Publication 7846, Foreign Consular Offices in the United States, available in many local libraries.

If no record of your birth certificate was found, a secondary record of your birth would be needed to serve its purpose. While not considered to be as reliable as an official birth certificate, secondary records can still help you obtain other forms of identification. These may include hospital records, census records, religious records confirming your birth date, a statement from the midwife that delivered you, early school records, and records of immunization.

HOW TO GET YOUR SOCIAL SECURITY NUMBER AND CARD:

Your social security number is a unique 9-digit number specifically assigned to you at birth if you were born in the United States. This number is essential for employment, income and tax purposes, benefits, banking, schools, hospitals, etc. It is crucial to keep this card in a safe place and only bring it with you when you need it. Most of the time, you will only need the number, so it is recommended that you memorize it.

- In-person application (recommended)
 - **Step 1**: Gather documents that prove your age, citizenship/legal presence in the U.S., and that you are still alive
 - Some primary documents that may prove all of these include a state-issued driver's license, state-issued ID card, or U.S. passport.
 - If you have never had a social security card and are applying for an original, you will need to provide more than one document proving this information.
 - If you do not have any of the above primary forms of ID, gather as much identifying information as possible for your application. The SSA will then decide whether it is enough proof of identity to provide you with your social security card.
 - **Step 2:** Go in person to the Social Security Administration and fill out the application
 - Step 3: Meet with an SSA employee to verify your identity
- **To apply by mail**, print out <u>the application</u> or call (800) 771-1213 and request them to send you one and fill it out to mail with your identity documents listed above. You will need to mail the original forms of these identity documents, not copies of them.

HOW TO GET A CA STATE I.D.:

- Step 1: Prepare the required information and documents
 - Social Security number
 - Proof of birth date and legal presence (U.S. birth certificate, U.S. passport, U.S.armed force ID card, Certificate of Naturalization, Permanent Resident card, or foreign passport with a valid I-94)
- Step 2: Go to your local DMV to submit your application
 - There is a \$28 fee that you will be asked to pay unless you are eligible for a fee waiver
 - If you receive public benefits, you can pay a reduced fee of \$8
 - If you are over 62, you can get a free ID
 - If you are homeless, you should be able to get a free ID
- You will receive a temporary ID until your official one arrives, but this may not be a sufficient form of identification in certain circumstances



HOW TO GET A DRIVERS LICENSE:


If you have never had a driver's license:

- **Step 1:** Fill out the <u>California Driver's License or ID Card Application</u>. You can also do this in person at the DMV, but it is recommended to complete it online in order to save time.
- Step 2: Visit your local DMV. Here you will need to:
 - Provide your California Identification Card or proof of identity and residency
 - Pay the application fee
 - Pass a vision exam
 - Take a photo
 - Pass the knowledge test based on the <u>California Driver's Handbook</u>
- Once the above is complete, you will receive a provisional instruction permit. This will allow you to drive legally as long as a licensed adult is in the car.
- Step 3: Take the behind-the-wheel driving test

If you have a valid driver's license issued by another state

- **Step 1:** Fill out the <u>California Driver's License or ID Card Application</u>. You can also do this in person at the DMV, but it is recommended to complete it online in order to save time.
- Step 2: Visit your local DMV. Here you will need to:
 - Provide your Social Security Number
 - Pay the application fee
 - Present an <u>acceptable identity document and acceptable residency</u> <u>documents</u>
 - Have your thumbprint scanned
 - Pass a vision exam
 - Have your photo taken
 - Pass the knowledge test based on the <u>California Driver's Handbook</u>

If your license has expired, go to your local DMV with you Social Security Number and proof of birth date, and legal presence along with the Application.

TECHNOLOGY

<u>California Lifeline</u> provides qualifying households discounted rates for cell phones and home phones. You can qualify based on income or the programs you are enrolled in. You can make free phone calls by connecting to free internet in places like a cafe or your public library without a data plan.

<u>Obama Phone</u> gives struggling low-income Americans free cell phones, voice minutes, and text.

Providers that offer the Affordable Connectivity Program (ACP), which gives quality free or discounted phones and data plans, include <u>Assurance</u> <u>Wireless, TrueConnect, Tag Mobile</u>, and <u>Tracfone</u>.

If you are unable to get a phone, you can still get a phone number and make free calls using <u>Google Voice</u>. Google Voice lets you make calls and receive voicemails on any computer connected to the internet.

<u>Google Hangout</u> is another free platform that allows instant messaging via a web browser or app when connected to the internet.

<u>Tech for Success</u> program aims to assist Riverside County families with emergency technology assistance to help bridge the digital divide. This program distributes refurbished desktop computers to those who complete the necessary tasks.

SO, WHAT ARE MY RIGHTS?

- Minimum wage in California is \$15.50
- Hourly workers should always be paid on time and for all time worked.
- Employers must have enough money to cover paychecks up to 30 days after the issue date.
- Employees are entitled to 1 rest period of at least 10 minutes for every 4 hours worked and 1uninterrupted meal period of at least 30 minutes for every 5 hours worked.

GET A LIBRARY CARD

A California Library card can give you access to so many resources for free. These recourses include computers, wifi, printing, free courses, and more! Several online decarceration resources are also listed on the Riverside County Library System website.

Any resident of California can obtain a Riverside County Library System card. A valid California Driver's License with a current address or two forms of identification, one showing who you are and the other indicating your current mailing address in California, are required to receive a library card. Non-residents of California can get a library card for a \$10 annual fee. You can register for a card either in person or <u>online.</u>

TYPES OF LIBRARY CARDS

- Adult California Residents Card: Can be used at any Riverside County Library System location as well as for online resources and must be renewed every three years.
- Internet Only: Can be used for access to library computers but not to check out materials. This card does not require address verification.
- **eCards:** Gives access to the library's digital collection of ebooks, eAudiobooks, eMagazines, and more.
